We do want to assure you that any sensitive information you provide is kept confidential (and locked in a safe) and any information we discover (in the process of doing background checks) will be handled discreetly.

We appreciate your understanding and cooperation with this process. If you have any questions or concerns, please don't hesitate to come talk to me or any of the pastors or staff at Heartland.
